

TRACK COMPETENT (TC) Joining Instructions

Please ensure you have all of the course pre-requisites with you as you will be unable to start the course without them

| Course Specific Pre-Requisite Checklist |

| <u>NEW</u> recent Colour Passport Sized Photograph on <i>Photographic Paper</i> . |
| Current Legally Recognised Photo Identification - Contractors only (Passport, Photo Driving Licence, CIS Card, or PTS Sentinel Card). Note: Tube Lines Employees will need their staff pass, or other proof of identification |
| Proof of National Insurance Number (NI Card, P45, P60, P46, Payslip or CIS Card) or Evidence of Entitlement to Work in the UK e.g.: Original Visa, Work Permit or Letter from the Home Office. Note: Tube Lines Employees will need their employee number instead |
| Proof of Current Address – (Recent Utility Bill, etc) - Contractors only |
| Proof of Date of Birth – (Passport, Driving Licence, Birth Certificate, etc) - Contractors only |
| <u>COMPLETED</u> and Signed Original Contractor Declaration Form - Contractors only |
| Current Entry Permit – Note: Must still be valid on the course date |
| Current Safety on the Track Certificated endorsed for Track and Depot Track Accustomed – Note: Must still be valid on the course date |
| <u>COMPLETED</u> and Signed Managers Declaration (TSW 031) stating completion of 5 full shifts in the main line environment and having the required ability and experience to attend the course |
| LU Approved Drugs and Alcohol Medical Screening Programme Certificate (D.A.M.S.P) – Contractors Only |
| Original Medical from an LU Approved Provider – TSW 027 for Tube Lines Staff and TSW 028 for Contractor Staff . (Medicals are valid for 5 Years from Date Stamp) If the Medical is older than 3 months, a TSW 024 must be completed and signed by your manager |
| If you wear spectacles or contact lenses, please bring these as there will be an eyesight test |
| PPE Requirements – Safety Footwear - Mid Sole Protected (BS EN ISO 20345) Orange Hi-Viz Vest (BS EN 471) and Safety Glasses (BS EN 166) |

Failure to produce any of the above documents WILL result in delegate turn away

Note: You must not work in the 12 Hours Before, or After attending this course

Note: The course starts with a Track Accustomed Test Paper which you must pass

Note: Please bring any previously issued Track/Protection Handbooks/Pocketbooks

Note: Track Walks may be carried out at another site, therefore please ensure that you have funds with you to buy an Underground Ticket
