Joining Instructions

Please ensure you have all of the course pre-requisites with you as you will be unable to start the course without them

Course Specific Pre-Requisite Checklist
<u>NEW</u> recent Colour Passport Sized Photograph on <i>Photographic Paper</i> .
Current Legally Recognised Photo Identification - <i>Contractors only</i> (Passport, Photo Driving Licence, CIS Card, or PTS Sentinel Card). Note: Tube Lines Employees will need their staff pass, or other proof of identification
Proof of National Insurance Number (NI Card, P45, P60, P46, Payslip or CIS Card) or Evidence of Entitlement to Work in the UK e.g.: Original Visa, Work Permit or Letter from the Home Office. Note: Tube Lines Employees will need their employee number instead
Proof of Current Address – (Recent Utility Bill, etc) - <i>Contractors only</i>
Proof of Date of Birth – (Passport, Driving Licence, Birth Certificate, etc) - <i>Contractors only</i>
<u>COMPLETED</u> and Signed Original Contractor Declaration Form - <i>Contractors only</i>
Current Entry Permit – <i>Note: Must still be valid on the course date</i>
Current Safety on the Track Certificated endorsed for Track Trolley Operator, Track and Depot Track Accustomed – <i>Note: Must still be valid on the course date</i>
If you wear spectacles or contact lenses, please bring these as there will be an eyesight test
<i>PPE Requirements</i> – Safety Footwear - Mid Sole Protected (BS EN ISO 20345) Orange Hi-Viz Vest (BS EN 471) Safety Glasses (BS EN 166) and Gloves (Optional)

Failure to produce any of the above documents WILL result in delegate turn away

Note: You must not work in the 12 Hours Before, or After attending this course

Note: It is recommended that you have a Manual Handling Certificate prior to start
